- The Bow-Tie models (**Models**); and
- Printed or online guidance material (**Documentation**).

We licence use of the Models and Document to you on the basis of this Licence. We do not sell the Models or Documentation to you. We remain the owners of the Models and Documentation at all times.

1. GRANT AND SCOPE OF LICENCE

- 1.1 In consideration of you agreeing to abide by the terms of this Licence, the Licensors hereby grants to you a non-exclusive, non-transferable licence to adapt and use the Models and the Documentation on the terms of this Licence.
- 1.2 You may adapt and use the Models for your internal business purposes only.
- 1.3 If you wish to use the Models outside your organisation you must first obtain our written consent.
- 1.4 You may only use the Models for the purposes for which they are designed, as described in the Documentation, i.e. for safety management within your organisation.
- 1.5 You must not transfer or copy the Models to anyone else without them agreeing to the terms of this licence.

2. INTELLECTUAL PROPERTY RIGHTS

- 2.1 You acknowledge that all intellectual property rights in the Models and the Documentation throughout the world belong to us, that rights in the Models are licensed (not sold) to you, and that you have no rights in, or to, the Models or the Documentation other than the right to use them in accordance with the terms of this Licence.
- 2.2 You must acknowledge us as the intellectual owner of the Models.
- 2.3 You undertake to include our copyright notice on all entire and partial copies of the Models in any form.

3. LIMITATION OF LIABILITY

- 3.1 You acknowledge that the Models have not been developed to meet your individual requirements, and that it is therefore your responsibility to ensure that the Models meet your requirements.
- 3.2 You acknowledge that you shall not rely on the Models, but undertake your own analysis to tailor the Models to meet your individual requirements.
- 3.3 We shall not under any circumstances whatever be liable to you, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, arising under or in connection with the Licence for:
 - (a) loss of profits, sales, business, or revenue;
 - (b) business interruption;
 - (c) loss of anticipated savings;
 - (d) loss or corruption of data or information;
 - (e) loss of business opportunity, goodwill or reputation; or
 - (f) any indirect or consequential loss or damage.
- 3.4 Nothing in this Licence shall limit or exclude our liability for:
 - (a) death or personal injury resulting from our negligence;
 - (b) fraud or fraudulent misrepresentation;
 - (c) any other liability that cannot be excluded or limited by English law.
- 3.5 This Licence sets out the full extent of our obligations and liabilities in respect of the supply of the Models and Documentation. Except as expressly stated in this Licence, there are no conditions, warranties, representations or other terms, express or implied, that are binding on us. Any condition, warranty, representation or other term concerning the supply of the Models and Documentation which might otherwise be

implied into, or incorporated in, this Licence whether by statute, common law or otherwise, is excluded to the fullest extent permitted by law.

4. TERMINATION

- 4.1 We may terminate this Licence immediately by written notice to you if you commit a material or persistent breach of this Licence which you fail to remedy (if remediable) within 14 days after the service of written notice requiring you to do so.

5. COMMUNICATIONS BETWEEN US

- 5.1 Any notice given by you to us, or by us to you, will be deemed received and properly served immediately when posted on our website, 24 hours after an e-mail is sent, or three days after the date of posting of any letter. In proving the service of any notice, it will be sufficient to prove, in the case of a letter, that such letter was properly addressed, stamped and placed in the post and, in the case of an e-mail, that such e-mail was sent to the specified e-mail address of the addressee.

6. OTHER IMPORTANT TERMS

- 6.1 This Licence constitutes the entire agreement between you and us. You acknowledge that you have not relied on any statement, promise or representation made or given by or on behalf of the us which is not set out in this Licence.
- 6.2 If we fail to insist that you perform any of your obligations under this Licence, or if we do not enforce our rights against you, or if we delay in doing so, that will not mean that we have waived our rights against you and will not mean that you do not have to comply with those obligations. If we do waive a default by you, we will only do so in writing, and that will not mean that we will automatically waive any later default by you.
- 6.3 Each of the conditions of this Licence operates separately. If any court or competent authority decides that any of them are unlawful or unenforceable, the remaining conditions will remain in full force and effect.
- 6.4 This Licence, its subject matter and its formation (and any non-contractual disputes or claims) are governed by English law. We both agree to the exclusive jurisdiction of the courts of England and Wales.
